The LL.M. in International Law is a one-year postgraduate degree programme that provides advanced, broad-ranging and practice-oriented training in international law. It allows students to tailor their studies according to their particular interests by choosing one of the three concentration streams offered: International Economic Law, International Environmental Law and Governance, and The Protection of the Individual in International Law.

Students in the LL.M. Programme gain exposure to world-renowned faculty, benefit from being at the heart of international legal affairs in Geneva, and share ideas with other participants from different legal backgrounds and perspectives.
